Workmen's compensation claims, disability benefits and other similar employees benefit acts;

Claims for damages because of bodily injury, occupational sickness or disease, or death of his employees, and claims insured by usual bodily injury liability coverage;

Claims for damages because of bodily injury, sickness or disease, or death of any person other than his employees, and claims insured by usual bodily injury liability coverage's; and

Claims for damages because of injury to or destruction of tangible property, including loss of use resulting there from.

CERTIFICATE OF INSURANCE: Before commencing any of the work, **Contractor** shall file with the **LMWD** valid Certificates of Insurance acceptable to the **LMWD**. Such Certificates shall contain a provision that coverage afforded under the policies will not be cancelled until at least fifteen days' prior written notice has been given to the **LMWD**.

Safety Provisions

Bidder shall provide barricades, flares, warning signs and/or flagmen so that danger and inconvenience to the public, and job site working personnel will be eliminated. In addition to any other requirements of the contract documents, the bidder shall be responsible for familiarity and compliance with all Federal (OSHA), State, and local safety rules laws and requirements and must be familiar with color code of chemical products to prevent accidents. Contractor must obtain a Confine Space Entry Permit from the District prior to commencing work.

Differing Site Conditions:

If, in the performance of the contract, subsurface, latent or concealed conditions at the site are found to be materially different from the information included in the bid documents, or if unknown conditions of an unusual nature are discovered differing materially from the conditions usually inherit in work of the character shown and specified, the LMWD shall be notified in writing of such conditions before proceeding with the work. If necessary, the solutions prompt changes to the Contract Amount and/or Time, the Contractor shall be adjusted under the changes clause.

Protection of Adjoining Property

The said contractor shall take proper means to protect the adjacent or adjoining property or properties in any way encountered, which might be injured or seriously affected by any process of ground maintenance to be undertaken under this agreement, from any damage or injury by reason of said process of construction; and he shall be liable for any and all claims for such damage on account of his failure to fully protect all adjoining property. The contractor agrees to indemnify, save and hold harmless the LMWD against any claim or claims for damages due to injury to adjacent or adjoining property, arising or growing out of the performance of the contract, but any such indemnity shall not apply to any claim of any kind arising out of the existence or character of the work.

Protecting Existing Structures and Facilities

Where excavation or demolishing endangers adjacent structures and utilities, the Contractor shall at his own expense carefully support and protect all such structures and/or utilities so that there will be no failure or settlement. Where it is necessary to remove services, poles, guy wires, pipelines or other obstructions, the Contractors shall notify and cooperate with the utility LMWD. In case damage to an existing structure or utility occurs, whether failure or settlement, the Contractor shall restore the structure or utility to its original condition and position without compensation from the LMWD.

Inspection of Site

Each Bidder shall visit the site of the proposed work and fully acquaint himself with the existing conditions there relating to construction and labor, and shall fully inform himself as to the facilities involved, the difficulties and restrictions attending the performance of the contract. The contractor, by execution of the contract, shall in no way be relived of any obligation under it due to his failure to receive or examine any form or legal instrument or to visit the site and acquaint himself with the conditions there existing and the LMWD will be justified in rejecting any claim for extra time, or compensation or both based on facts regarding which contractor should have been on notice as a result thereof. Addenda and Interpretations


No oral interpretations by LMWD and its representatives shall be binding upon LMWD as to the meaning of the plans, specifications, or contract documents. Every request for such interpretation should be made in writing, addressed to the A/P & Procurement Agent of the Laguna Madre Water District 105 Port Road, Port Isabel, TX 78578 and must be received prior to the opening of bids in order to be considered. It will be the bidder's responsibility to inquire as to any addenda issued and failure of any bidder to receive any such addenda or interpretation shall not relive such bidder from any obligation under his bid as submitted. All addenda so issued shall become part of the contract documents.


Correction Period


If within one year after the date of Final Acceptance by Owner any Work is found to be defective, or if the repair of any damages to the land or areas made available for Contractor's use by Owner is found to be defective, Contractor shall promptly, without cost to Owner and in accordance with Owner's written instructions:

- 1. repair such defective land or areas; or
- 2. correct such defective Work; or
- 3. if the effective Work has been rejected by Owner, remove it from the Project and replace it with Work that is not defective, and
- 4. Satisfactorily correct or repair or remove and replace any damage to other Work, to the work of others or other land or areas resulting therefrom.






PARAPET DETAIL

Door Type Elevations




Roof Plan
